Subject : MPC COVID-19 MEASURES [CONT.] DURING TRANSITION PHASE OF
NATIONAL COVID-19 RECOVERY FRAMEWORK

Dear Concerned,

Reference to the Transition Phase of the National COVID-19 Recovery Framework by the Prime Minister's Office (PMO) of Brunei Darussalam announced on 9th November 2021 (refer Attached), MPC Management would like to highlight to all shipping and forwarding agents, and port stakeholders herein "**MPC Clients**" that **effective 19th November 2021**:

1. MPC Clients **must** be fully vaccinated (at least 2 doses) prior entering any MPC premises.
2. MPC Clients **must** undergo COVID-19 PCR or Antigen Rapid Test (ART) atleast **once a week**.
3. To scan Bruhealth QR Code (**only** Green and Yellow Codes are permitted), undergo temperature check (temperature above 37.3°C will **not** be permitted) and to wear face mask prior entering **all** MPC premises including Muara Conventional Terminal (MCVT) and Muara Container Terminal (MCT).
4. Prior entering MPC premises, MPC Clients are **required** to present:
 - **Recent negative weekly** ART test result (endorsed by company management).
 - Identity Card or Driving Licence or Passport (for verification purposes).

Failure to show the above shall be **denied** entry.

5. Face masks **must** be worn at all times **prior entering and inside** MPC premises (regardless of their vaccination status). All face masks must be worn in a correct manner – must cover the wearer's nose and mouth.
6. To **exercise** COVID-19 Preventative Measures at all times such as maintaining social distance (at least 1.5 meters) and ensure personal hygiene (sanitization and washing of hands).
7. Strictly **no** interaction with oversea and onboard crews.
8. Mass gathering is **not** allowed are allowed at all times in MPC premises, unless with permission from MPC Management and strict accordance with MOH's Guidelines.

9. **Maximum of only two (2) representatives** from each organization shall be allowed to enter the port for operations related to vessel and cargo for shipping agents and forwarding agents only. Stevedores and visitors to enter the port are subject to MPC management's approval.
10. **Only one (1) representative** (excluding driver) from respective company is permitted for the documentation and application purposes.
11. Number of clients at **one time** for the following MPC premises are as below:
 - Finance CFS Counter - 3
 - MPC HQ Reception Area - 2
 - Control Room Reception Area - 2
 - Tally Counter - 2
